RESPONSE

TWENTY FIVE PERSONS WERE CONSULTED FROM CIRCLES NETWORK CHARITY GROUP AND THE SYDNI CENTRE IN LEAMINGTON SPA.

MOST PEOPLE HAD SEEN THE LOCAL PLAN.

THE MAJORITY OF PEOPLE COMMENTING DID NOT AGREE ON 12,300 NEW HOUSES WERE NECESSARY NEITHER ARE THEY WANTED BY THE LOCAL POPULATION. THERE ARE MANY HOUSES STANDING EMPTY.

CONCERNS WERE RAISED OVER THE PROPOSED NEW SITES BEING ON GREEN BELT LAND.

POLLUTION IS ALSO OF CONCERN.

HOSPITALS AND DOCTORS SURGERY'S CANNOT COPE WITH THE POPULATION WE ALREADY HAVE.
