The policy in the Draft Local Plan will list the criteria by which Gypsy and Traveller sites will be judged for suitability and sustainability. These are the criteria:

- Convenient access to a GP surgery, school and public transport;
- Avoiding areas with a high risk of flooding;
- Safe access to the road network and provision for parking, turning and servicing on site;
- Avoiding areas where there is the potential for noise and other disturbance;
- Provision of utilities (running water, toilet facilities, waste disposal, etc);
- Avoiding areas where there could be adverse impact on important features of the natural and historic environment; and,
- Sites which can be integrated into the landscape without harming the character of the area.
- Promotes peaceful and integrated co-existence between the site and the local community;
- Avoids placing undue pressure on local infrastructure and services;
- Reflects the extent to which traditional lifestyles (whereby some travellers live and work from the same location thereby omitting many travel to work journeys) can contribute to sustainability.

**GT 06 does NOT have:**

- Any local Amenities. The nearest GP is over 1 3/4 miles away at Cape Road, the nearest school is 1 1/2 miles away in Buzford, the nearest public transport is the Bus with stops in Buzford 1 3/4 miles away for the X15 or X15a and over a mile away at Gallops Hill for the No. 68.
- There is no easy road access. The whole site is bordered by roads with National speed limits at 60 mph, as even then due to the very straight nature of Buzford Road (formerly Flat Rabbit Lane) vehicles do well in excess of 20 mph frequently. There are always accidents on this road and in 2011 records from WCC specify 13 casualties. I have no records for 2012/2013 but know of at least one fatality on Buzford Road.

Response for objection to site G706 - continuation.

- This proposed site is bordered by 3 fast roads and is less than 200m away from the M40 at its most westerly point. All the plot is within 1000m of the M40 and ~~it~~ will be extremely noisy for any resident especially as the motorway is not cut in out this point and any noise will be transferred by the mostly prevailing South Westerly wind. The site will be barely liveable this close to the motorway.
- This proposed site has a very prominent telephone Mast in its North Eastern position. There is much ~~proof~~ evidence and speculation that these mobile TV mast cause health issues with narrowband and microwave transmission signals. Enough for the WHO and the International Agency for Research on Cancer has classified mobile radiation on the IARC scale into group 2B - POSSIBLY CARCINOGENIC. Despite the government's STEEP report opinion is still divided and residential masts are not ~~just~~ recommended.
- The proposed site has no ease of access to utilities. There is no gas main locally, no water or waste/sewage ~~system~~ so any utilities will have to be purpose built.
- The site borders a historic monument site 'Warwick Castle Park' that has many archaeological and ecological points of interest. Siting a G7T site so close will put both of these under threat. The historic environment of the park has been debated and protected for many years. including/by WDC, WCC, WCC Ecology Unit, WCC Heritage and archaeology, WCC Parks and access, English Heritage, the Garden History Society, Stratford and Warwick Waterways Trust, The Warwickshire Wildlife Trust, ~~and~~ the Warwick Society and The Warwick Castle Park Trust. All of these will want to protect the park at all costs and would not want a G7T site on their doorstep.

In addition to the above the site is proposed on ~~the~~ grazing farmland and would NOT be integrated into the landscape.

A G+T site located in GTO6 would be very visible for all coming in and out of Wakefield from J13 by the M40 and would not help for tourism of our beautiful town.

- This location would not promote peaceful and integrated co-existence. If G+T want to be integrated into society they need to be sited in society not planted in the middle of a field surrounded by countryside and no amenities.
- Site GTO6 would place additional pressure on amenities in Bayford school even though they are not local.
- The proposed site is located on a disused/closed landfill site. This is one of the 18 closed landfill sites in Wakefield.

The fundamental issue here is that there should not be two local plans - one for G+T's and one for future housing. They should be integrated and planned together so that the G+T sites are integrated into the new builds for housing.

I suggest that the total of 31 pitches for G+T's are placed within the Southern Sites of Warwick and Witnash in the Strategic Urban extension sites referred in the WDC's current Revised Development Strategy 2013.

That as WDC/WCC look at changing the green belt policy that has protected the Northern parts of the county. It should reflect the need of the county and to have all G+T sites in the south doesn't reflect ~~what~~ a county-wide policy.


