

The policy in the Draft Local Plan will list the criteria by which Gypsy and Traveller sites will be judged for suitability and sustainability. These are the criteria:

- Convenient access to a GP surgery, school and public transport;
- Avoiding areas with a high risk of flooding;
- Safe access to the road network and provision for parking, turning and servicing on site;
- Avoiding areas where there is the potential for noise and other disturbance;
- Provision of utilities (running water, toilet facilities, waste disposal, etc);
- Avoiding areas where there could be adverse impact on important features of the natural and historic environment; and,
- Sites which can be integrated into the landscape without harming the character of the area.
- Promotes peaceful and integrated co-existence between the site and the local community;
- Avoids placing undue pressure on local infrastructure and services;
- Reflects the extent to which traditional lifestyles (whereby some travellers live and work from the same location thereby omitting many travel to work journeys) can contribute to sustainability.

Do you have any other suggestions for land within this district that you think would be suitable for use as a Gypsy and Traveller site, bearing in mind the criteria for site identification? If so, please give the location and the land owner's details below:

- 1/ The site would be an eyesore both from the A4177 and the canal, and the noise created by gypsies/travellers moving on and off the site, working there plus children and dogs, would be unacceptable especially to residents nearby.
- 2/ The A4177 is already extremely busy, causing queues of traffic several times a day. The site would increase traffic, emissions, air pollution, bottlenecks & noise. The speed limit is broken continually which would add to the danger to children particularly, & anyone trying to cross the road to the bus stop etc. The Shell garage adjacent to the site is open 24hrs & will add to the pollution inhaled by residents on the site.
- 3/ This is Green Belt land which should not be developed, plus the site is adjacent to the Hatton Flight of locks on the Grand Union Canal, historically known as the Stairway to Heaven which attracts large numbers of visitors, including very many walkers. Such a development would have a great adverse effect particularly on the visual beauty of this area. This heritage dates back over 200 years. An increase in human activity would also have an adverse effect on the flora/fauna, including several endangered species. The canal would also attract children and be a danger to them from serious illness & or drowning.
