The area west of Watery Lane straddles public bridle path, a form-access track and access to Hooknell Cottage Ardenhill Cottage which operates a kennels business. The presence of a gypy/traveller site in the immediate vicinity may impact the farm and kennels businesses and compromise the use of the public right of way.

All this land is in the Green Belt and is productive farmland, the loss of any part of which could adversely affect the livelihood of one of the farmers who currently work it.
