# Barford Residents Association Community Consultation

Warwick District Council is currently consulting local people on sites suitable to accommodate the permanent residential needs of the Gypsy and Traveller Community and Travelling Show People. This consultation, which is running alongside that for the Local Plan, **closes on 29<sup>th</sup> July 2013.**

A study for the Council was undertaken by Salford University and identified a requirement for 31 permanent pitches to be provided in the District over a 15 year period, of which 25 should be provided within the first 5 years. In addition there is a need for a 12 pitch transit site.

Using a series of criteria, the Council have identified 20 sites and/or areas of search, which are shown on the map below.

11 sites and/or areas of search are within 3 miles of Barford.

We would like to know what you think about these proposals. The consultation document, which sets out the criteria and the site boundaries, can be viewed on the Council's website [www.warwickdc.gov.uk](http://www.warwickdc.gov.uk).
