- Convenient access to a GP surgery, school and public transport;
- · Avoiding areas with a high risk of flooding;
- · Safe access to the road network and provision for parking, turning and servicing on site;
- Provision of utilities (running water, toilet facilities waste disposal etc);
- Avoiding areas where there could be an adverse impact on important features of the natural and historic
  environment; and,
- Sites which can be integrated into the landscape without harming the character of the area.
- Promotes peaceful and integrated co-existence between the site and the local community;
- · Avoids placing undue pressure on local infrastructure and services;
- Reflects the extent to which traditional lifestyles (whereby some travellers live and work from the same location thereby omitting many travel to work journeys) can contribute to sustainability.

# Gipsy site fears for guide dogs

Plans to put a gipsy camp alongside the main Banbury Road near Oakley Wood have brought strong protests - including one from the Guide Dogs for The Blind Association, worried that gipsy dogs could bring disease to its breeding centre nearby.

The breeding centre is at Tollgate House, and manager Mr Derek Freeman told the MN there had already been problems with gipsies who had camped on the proposed site in camped on the proposed site in the past.

He was particularly con-cer 1 about gipsy dogs can ng diseases.

cai ing diseases.

"The close proximity would present us with problems if they carried disease. Parvo virus has been rife round the country over the past two years. There is some young, extremely valuable stock on the premises which we have built up over the years."

Travelling dogs can also bring problems to farmers,

carrying diseases like fowl-pest and swine vasicular disease," he said.

disease," he said.

Mr Freeman and his family live at Tollgate House with some eight residents.

"In the past we have had gipsies calling at the doors and some have been a worry,"

"I, as an individual will be protesting because I live on the site and my family live here too."

Mr Michael Thornton, who owns nearby Hogbrook Farm, said the site was a waste of

money.

"Gipsies have a bad reputation," he said. "I can see them pinching the pheasants. There are enough people walking through the crops and that sort of thing. They tend to leave a mess beside the road because they never fidy up. because they never tidy up when they come.

"And they don't have a reputation for honesty."
Mr Thornton, asked where

the mains water for the site

was coming from.

Com Bernard Kirton who has led the fight against a camp being established anywhere in Warwick district, says he has been contacted by local people complaining about the proposed site.

Coun Kirton said residents who called him were furious. They had had gipsies before in the layby and they had chopped down trees.

"One of the reasons this site

appeals to officers is that it is

an isolated area. My attitude is that three families have as much entitlement to their rights as 300," he said. The district council has de-

layed its decision on the site while the county council re-considers its policy on gipsy

site provision.

The 13/14 pitch camp would be in an area of woodland opposite the Moreton Morrell junction, on the Learnington side of the main road.
