Dear Sir

I have looked at the proposed sites for travellers that are indicated on the Council's web-site. The sites numbered 12 and 16 are situated quite close to Mill Lane and having taken a look at the locations I think it worthwhile making the following observations.

The land on which the sites are to be situated lies well below the road level of the A429 by-pass and would require some considerable engineering work to create an access that would be safe for caravans and presumably the Council's waste collection vehicles given that the by-pass carries fairly fast moving traffic that does not always respect the speed limit.

The site at No.16 is immediately adjacent to the river Avon which has been prone to flooding at the Barford Bidge in recent years. I'm not certain that the location at 16 has been completely under water but it must have been very close to it. In any case the water table must be near to the surface at these two proposed sites and this should raise questions about the suitability of them as places for people to live healthy lives unless extensive building work is carried out in order to screen the sites from moisture.

The proximity to the river of both 12 and 16 would I suspect, create the possibility of the river becoming polluted at some point in the future. Travellers who have made use of temporary sites in the Warwick area have tended the leave a good deal of waste behind them when they have left.

Finally there is the question of access to Barford village. There is at present no specific pedestrian access to the village from the proposed sites 12 and 16. To cross the A429 would not in my opinion be safe for children unless a traffic light controlled pedestrian crossing were to be installed and I'm guessing that this would require a reduction in the present speed limit for the by-pass.
