## Criteria by which Gypsy and Traveller's sites will be judged for suitability and sustainability by Warwick District Council:

- Convenient access to a GP surgery, school and public transport;
- · Avoiding areas with a high risk of flooding;
- · Safe access to the road network and provision for parking, turning and servicing on site;
- Provision of utilities (running water, toilet facilities waste disposal etc);
- Avoiding areas where there could be an adverse impact on important features of the natural and historic
  environment; and,
- Sites which can be integrated into the landscape without harming the character of the area.
- Promotes peaceful and integrated co-existence between the site and the local community;
- Avoids placing undue pressure on local infrastructure and services;
- Reflects the extent to which traditional lifestyles (whereby some travellers live and work from the same location thereby omitting many travel to work journeys) can contribute to sustainability.

I AM OBJECTING TO PROPOSALS TO LOCATE A GYPSY/TRAVELLER SITE ON LAND THAT IS PART OF, OR ADJACENT TO, THE WARWICKSHIRE EXHIBITION CENTRE ON THE FOLLOWING GROUNDS:


- A) Having been recently dismissed from the GP Surgery List where we had been registered for over 40 years on the grounds that they were oversubscribed, AND having found difficulty getting another one, I believe that those living on this proposed site will further over-crowd those lists. It is unfair that a transient population with increased risks of illness or injury resulting from their life-style should become a burden on the local NHS services.
- B) The entrance for the proposed site will, on whichever of the two roads it is located, will be on a high-usage route, both roads having a high risk of accidents. This high risk situation will be exacerbated by pedestrian and/or cycle user from the site, as NEITHER of these roads have ANY pedestrian or cycle paths.
- C) The resulting closure, on financial AND anti-social grounds, of the Warwickshire Exhibition Centre will result in the loss of a valuable local asset, which has been built up carefully and soundly over recent years. Jobs and visitor income will be lost, but even if the establishment managed to stay open, their costs would increase substantially by virtue of the need to significantly improve their security and safety measures due to the proximity of the travelling community with their disregard for the sanctity of other peoples property, and for the reduced levels of hygiene, health and safety of the environment caused by the way they choose to live.
- D) The peaceful rural views and the quietness of the locality will be destroyed by the presence of the site, with fluctuating population and garish mobile homes. Most sites of this nature also produce unpleasant smells, which will make gentle walks in the area a thing of the past.
- E) The site and it's occupants will also have some impact on the wildlife in the area, which will be disturbed by noise, human activity and deposits of various sorts of waste, risking the already delicate balance of natural life in the area.
- F) The site in question has a record of historic importance and archaeological significance, and should not be allowed to be disturbed by such a use.
- G) In view of Warwickshire C. C.'s current practice of turning off street lighting in the dark hours, I fear for the safety and security of the properties within Radford Semele, the nearest residential centre to the proposed site.

Warwick District Council will judge proposed sites against the nationally accepted criteria. The purpose of the criteria is to seek to meet the requirements of the Gypsy and Travellers community not necessarily local residents, businesses and employment.

Areas of concern could include:

• Agriculture • Animal Welfare • Co-existence • Crime • Ecology and Habitat • Education/Schools • Healthcare/
Surgeries • Highways and Safety • Local Economy • Rural Landscape • Services and Utilities • Tourism • Traffic Density/
Flow • Urbanisation.

I AM OBJECTING TO PROPOSALS TO LOCATE A GYPSY/TRAVELLER SITE ON LAND WITHIN WARWICKSHIRE (OR INDEED ANYWHERE) ON THE FOLLOWING GROUNDS:

The travelling community, by the very nature of their mobility, present Local Authorities with substantial problems relating to the planning, provision and costs of services. The sites have to be built to meet current planning standards, will need to be maintained and serviced, provided with systems for energy, waste and protection, all for a transient population which has a history of ignoring the needs of permanently resident neighbours, whether domestic, agricultural or business.

I consider it to be wholly unjust that a very small minority of the population of this country should command a disproportionately high cost per head for the provision of any Local Authority provided facility or service. Even if the travellers were to be model citizens, by the current and sometimes doubtful standards of the 21<sup>st</sup> Century, the costs that their life-style requires is unacceptable. But history shows that they are NOT even remotely thought of a model citizens, and the negative impact on any community should not EVER be tolerated. In addition to the costs of providing services, there is extra and usually substantial cost of these negative elements. Probably the most significant additional cost will be for the extra policing, and along with the other Local Authority costs this will be borne by local residents.

Agriculture and wild-life are at risk from the blatant disregard usually exhibited by these travellers in the matter of waste disposal - of ALL types, whether it be human, animal or industrial.

The impact of travellers children on the stability of the school classroom by virtue of their different levels of ability and attendance will cause problems for permanent resident children whilst the travellers catch up.

I also believe that the presence of a travellers site, with it's usual attendant risk to personal property, will quite possibly see an increase in insurance premiums, especially Home & Contents.

I believe very strongly that it will be very unsettling for ANY community to have a Gypsy/Travellers site close by, and that it is unjust and unacceptable in this day and age for such a small minority to cause such disarray and additional expense to Local Authorities and it's taxpayers.
