I wish to protest in the strongest manner regarding this site.

In recent years there have been 3 rejected planning applications on this site, all for reasons that are still very valid. The access to the site, on a very fast road, where very few drivers adhere to the speed limit, is very dangerous, being on a bend on the brow of a hill and there is also an injunction, preventing development of this site

There is also a high voltage power line running across the site, which also makes it totally unsuitable for any development purpose.

The only reason that the owner is keen to use this site for this purpose is that along with his recent planning rejections, he has been unable to sell the land and allowing it to be used for this purpose would be a way at getting back at the Council, who rejected his plans and the local people who objected to them.

In view of the previous rejected planning applications for this site, the Council would be leaving themselves open to ridicule if they were to do a "U turn" and allow this site to be used.

I wish to object most strongly to the use of this site on the basis of the confined access to the site.

The turning off, the very fast Birmingham Road, very few drivers respect the 40mph speed limit, is dangerous enough, being very close to a petrol garage, but the turning into the site off Ugly Bridge Road is extremely narrow and totally unsuitable for large vehicles such as travellers caravans.

Also the entrance is very close to the brow of the canal bridge and traffic approaching along Ugly Bridge Road would not been able to see vehicles turning into the site until they were on top of them.

For this reason alone, the site is totally unsuitable for this purpose.
