

## LOCAL PLAN FOR THE FUTURE DEVELOPMENT OF WARWICK DISTRICT

In general the latest plan is to be applauded but with one exception, that is the vague proposal for a Park & Ride Scheme north of Leamington in Blackdown parish. As such it is generally held in the community that we are at one with the Parish Council in its support for this plan and perplexed that such a poorly considered proposal for an undefined Park-and-Ride appears to take such a prominent position in planning for the future and which will in its present form be unused and a grotesque waste of public finds. Please see later in this letter when comment is made in this regard.

The District Council is to be complemented on this its latest version of the Local Plan. Specifically I am relieved and delighted that Green Belt has been spared, notably north of Leamington where the existing residual Green Belt is vulnerable to being lost and the conurbations of Coventry, Kenilworth Leamington & Warwick are at considerable risk of merging into the 'West Midlands' conurbation and so losing their individual character and identity.

The plan has also ensured that the best use is made of existing infrastructure to the south of Leamington which will continue to maintain a thriving business community and housing to service existing and developing business opportunities with the easy access to public transport in the form of road, rail, cycle and pedestrian routes; and to improve amenities in south Leamington and Warwick. To have developed north of Leamington would have required a duplication of much that already exists south of the town and would have lost the opportunity to improve existing infrastructure and make good deficiencies which are well known and recently well publicised particularly by those living in the area

### Reference - section 4 of Local Plan response sheet

One drawback with this plan, is the rather vague indication of plans to develop a Park and Ride provision in the Blackdown parish which relies on existing bus services and which we locally believe will not work, for the following reasons:

Far better if a Park and Ride scheme is required, and please note the necessary surveying and testing remains outstanding, would be to create a much larger development as part of the Thickthorn development south of Kenilworth to better serve both Warwick and Leamington as well as Kenilworth and Coventry.

Perhaps better still, would be to consider development to take full advantage of the existing opportunities for transport and parking associated with Warwick Parkway and cater for a greatly enhanced provision for Warwick, in an effort to reduce traffic congestion and environmental pollution which have been such a feature of recent protest and objection for plans to capitalise on the developmental potential in and around Warwick as well as south Leamington.

We look forward to seeing detail of the District Council's deliberations concerning this vexed question of making Park and Ride provision for which there is extreme danger that it will not be used and become an expensive 'white elephant'.
