- 7) The Local Plan is considered unsound on the following grounds where there is either no consistency with national policy or the proposal is not justified in the proposed area at Blackdown being included within the areas of search for a park and ride.
- 7.1) The areas of search for a park and ride are not consistent with, and conflict with, National Planning Policy Framework paragraph 90 as being inappropriate development in the green belt.
- 7.2) The areas of search are not consistent with, and conflict with, National Planning Policy Framework paragraph 80 and the five purposes of green belt, none of which are justified here.
- 7.3) In considering P&R in the Blackdown area, this would be contrary to the strategic approach of the Local Plan which concentrates future housing growth to the south of Leamington. There is no proven justification for P&R to the north of Leamington.
- 7.4) The inclusion of Blackdown in the area of search is not justified under the Warwickshire County Council Warwick Strategic Transport Assessment Phase 3 by Arup which states that the reasons to justify a P&R to the south of Leamington and Warwick are:
  - i) The focus of growth is in this area and thus has potential to mitigate a higher proportion of the impact.
  - ii) The site location would be able to serve both town centres.
  - iii) The number of highway mitigation schemes identified in this area which can more easily be adapted to provide bus priority systems would help to provide a viable service.
  - iv) The existing and new bus services that are required for the southern quantum of development would also be able to serve the P&R

None of these reasons are appropriate and justify any consideration of a site to the north of Leamington:

- The area of growth proposed for Leamington is to the south which it states has potential to mitigate the impact which would not be applicable in a site to the north.
- A southern site would serve both town centres whereas Blackdown would not.
- In the south the number of highway mitigation schemes identified in the area can be adapted to provide bus priority systems whereas the report goes on to say, with reference to a site to the north, "however the potential to provide bus priority infrastructure on the A452 corridor is limited".

This is the same as saying that a scheme is not technically deliverable along the A452 corridor.

- 7.5) The policy as stated is not justified because, even if there was a justification for a P&R to the north of Learnington, it is considered the area of search should sensibly be focused on the A46/A452 junction. It is normal to site P&Rs on major road infrastructure junctions and the area of Blackdown is just not suited to this.
- 7.6) Including the area of Blackdown in the area of search is not justified per reference to the Strategic Housing Land Availability Assessment May 2014 which describes this area as one of "high landscape value".
- 7.7) The inclusion of Blackdown is not justified because this area is basically "residential" in nature and the area of search should be nearer the A46/A452 junction.

8) The proposals should be modified to show the areas of search as geographically consistent with the areas of residential growth and should not conflict with national planning policy with regard to green belt.

If P&R to the north of Leamington is considered viable and justified then it should be adjacent to the A46/A452 junction and this area should be substituted for Blackdown.
