Dear Sirs.

Having reviewed the proposed 'Focused Changes' to the Local Plan Submission, The Parish Council wishes to record its continued, general support for the Local Plan, subject to the following observations:

- 1. We note from the supporting SHLAA exercise which was not available at the time of our original representation on the 'Submission Draft' that the parcel of land to the East of Warwick Road (adjacent to the cricket club), now proposed to be incorporated into Kenilworth, has been brought into the SHLAA as land suitable for development. This confirms our fears regarding the gradual southward expansion of Kenilworth towards Leek Wootton. We therefore wish to register the Parish Council's opposition to further incursions into the Green Belt separating Kenilworth from Leek Wootton.
- 2. Having considered the range of options available for the location of a Gypsy and Travellers site and recognizing this as a sensitive subject, we are broadly in support of the WDC proposal for a location at Stratford Road, Warwick.
