As a Westwood Heath resident for 22 years, the current infrastructure will NOT support further housing.

In the next 5 years, the NAIC will be completed and see extra cars/employees using Warwick University as will the Wellness Centre and Sports Facility.

Work on HS2 will have commenced and as I understand it the heavy traffic will be adjacent to the proposed housing site along Bockendon Road and Westwood Heath Road.

Crackley Lane and Gibbet Hill Road are not safe for increased volumes of traffic, let alone HGV traffic. Westwood Heath struggles at peak times now with traffic. I

Businesses are struggling on Westwood Business Park. There are empty office buildings because no one wants to rent them, and employers are struggling to recruit new staff now, due to access issues locally.

Construction of the proposed link road would alleviate these problems and is needed before the housing is put in. Please do this in the correct order. Infrastructure first.
