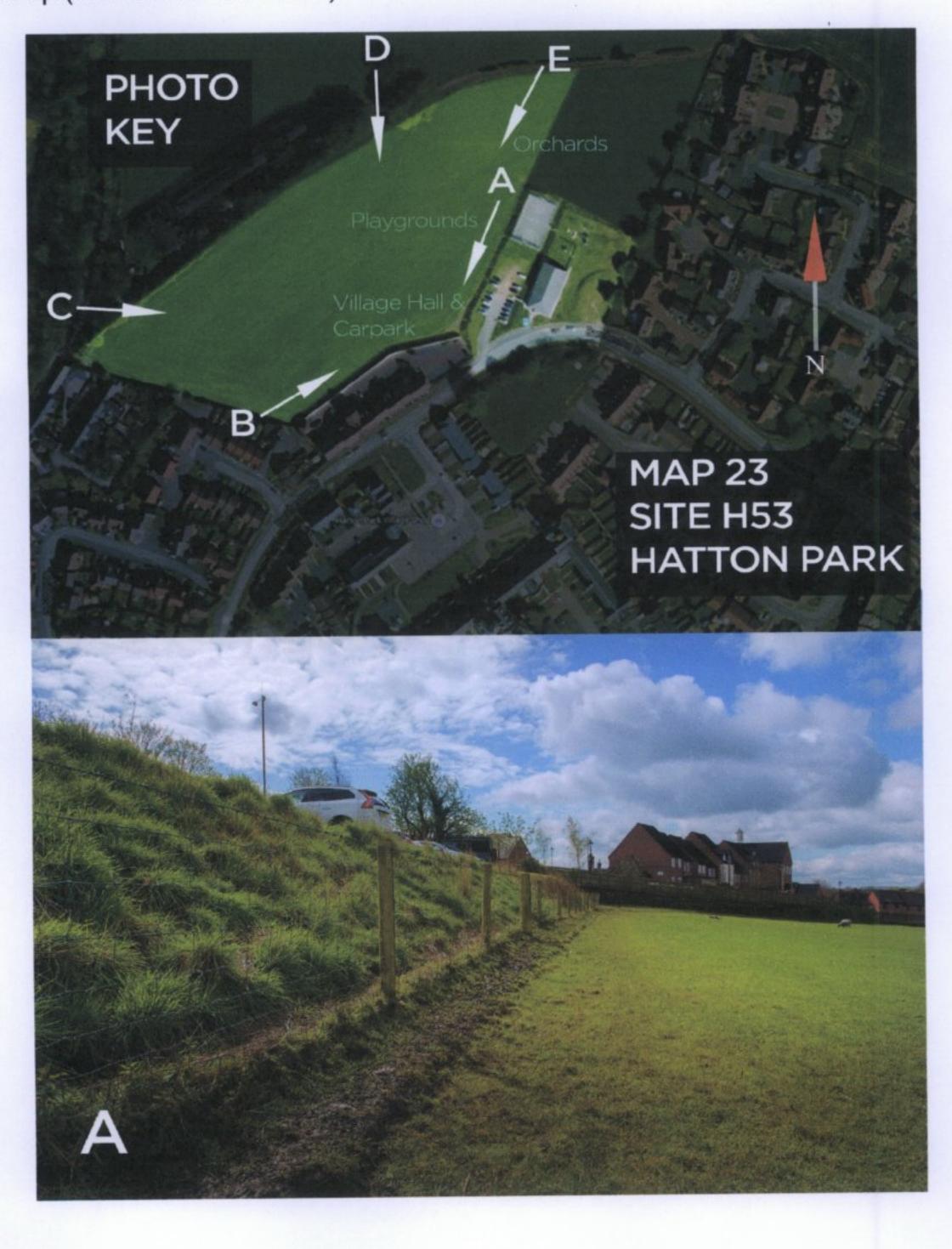

Q7. Please give details of why you consider the Proposed Modifications to the Submission Warwick District Local Plan are not legally compliant or are unsound. Please be as precise as possible.

The proposed modifications to MOD 19/ Site 53/ Hatton Park are unsound due to:

I. Restricted Access.

The proposed access to the site is severely restricted being on a steep gradient and on a bend in the road. Safe vehicle access to the site, requiring splayed entrances that conform to Highway requirements would be unachievable with the space available and proximity of village hall, it's carpark, the playgrounds and bus stop. (see Attached Photos A-E)





2. Conflict with Local Amenities:

The proposed site and proposed access is immediately adjacent to the Village Hall, Car Park a Childrens Playground, a Sports Ground, Community Orchard and Bus Stop. It would be impossible to develop the proposed site without either destroying or making all the aforementioned areas dangerous to use. These amenities are valued and well used by the Hatton Park Community, they are the only such amenities available to them and should be protected. (See attached Photos)

3. Site Limitations

The proposed site is across a steep gradient falling away from the highest point on Hatton Park, it's status as **Greenbelt** along with poor access, problems with drainage and water supply are why is was not developed previously.

i)These topographic problems remain and would require a considerable amount of civil engineering and groundworks to resolve.

ii) The nearby water pumping station that supplies more than 700 homes above it on Hatton Park is already at capacity, frequent breakdowns in supply are common.

iii) The environmental impact has not been considered, nor the impact of heavy plant machinery and HGVs during construction phases. Both would prevent local residents from having the quiet enjoyment of their homes and gardens to which they are entitled.

4. Inadequate Infrastructure

Local infrastructure to Hatton Park is already under significant strain. The Birmingham Rd adjacent and less than 500m from the site is a heavily used commuter road for Warwick, Leamington and for access to the A46 and M40. Further volumes of traffic make an increase in recent accidents & fatalities inevitable. There considerable short comings in local facilities for Healthcare and in particular local schools, already at capacity.

5. Draft local plan inconsistencies

The draft local plan provides no explanation of the sudden need to increase housing allocations and does not refer to other sites that could be considered. Poor analysis of population statistics and reactions to blips in data are misleading results that would not stand up to proper scrutiny.

6. Permanent loss of Greenbelt

The site is located in and part of a greenbelt area offering spectacular views of open countryside much enjoyed by the many residents of Hatton Park. Areas adjacent are specifically identified as wild life corridors needing greenbelt to support a diverse ecosystem. Poorly considered development puts these areas at particular risk and their destruction becomes an unchangeable legacy for future generations.

Response to Q.8 Necessary Changes to the Proposed Modifications

Other sites in the vicinity previously considered as Traveller sites represent a better overall alternative for residential development. Although the same concerns over local infrastructure remain it offers more suitable and sustainable area to develop and have limited impact to the existing Hatton Park development or local inhabitants.
