Removal of land north of Milverton is unsound because the case has not been made for exceptional circumstances as required by the National Planning Policy Framework.

There is land available nearer to Coventry which is of 'less value' to the green belt. To use the land in Old Milverton would reduce the green area between Leamington Spa and Kenilworth to little more than a narrow strip.
