There is green belt land of less value closer to Coventry. Removal of green belt land in Old Milverton will reduce the effective distance between Leamington and Kenilworth to a narrow strip. Therefore a case has not been made for the exceptional circumstances required by the National Planning Policy Framework

The area around Old Milverton is used by walkers, runners and cyclists. Access to Old Milverton Church and the the Saxon Mill is by Old Milverton Lane and its development is unsound as it would diminish the rural atmosphere which is of benefit to the residents of Leamington and Warwick.
