1. Barcheston drive is too narrow for Lorry and heavy plant movement during the construction, the local bus already struggles. They may use pathways presenting danger to pedestrians.
 2. Proposed access from village hall car park is steep to counteract this more land could be required above and impact the village hall, playground and car park spaces.
 3. children play area would become dangerous as close to access road and due to increase traffic.
 4. wider infrastructure (Birmingham Road) will struggle to support the additional traffic. At peak time the road is already congested with commuters and school runs.
 5. There has been a number of fatalities on that road (or serious accident) in recent years and increase traffic will likely increase these occurring.
 6. The housing need in the region are based on a blip in demand, growth will not necessarily follow same trajectory. we also question the decision to remove green belt as a result of this.
 7. The site is unsustainable environmentally as the lack of infrastructure requires additional car use
