It is proposed to remove land at Westwood Heath Road (H42) from the Green Belt so that it can be allocated for housing.

This land forms a key part of the West Midlands Green Belt which since being established has very effectively fulfilled four of its intended purposes by checking the sprawl of Coventry, preventing merging between Coventry and Kenilworth, safeguarding the encroachment of open agricultural countryside and assisting with urban regeneration. Indeed in Mod 20 the Policy DS New 1 f) states "The Green Belt between Coventry and Kenilworth should be protected."

The current boundary of the Green Belt is defined by the County boundary and identified physically by the clearly recognisable and permanent line of Westwood Heath Road. Development within Coventry in the last few years has filled in the land on that side resulting in a rather hard but obviously defined edge to the City.

Nearby it is proposed to remove the village of Burton Green from being washed over by the Green Belt and the new boundary is in that case clearly defined by the back boundaries of the gardens of the houses.

In contrast the proposed area for removal, designated H42, would result in a complex and illogical Green Belt boundary based apparently on field boundaries which are neither obvious boundaries nor permanent. Indeed standing on the ground it is quite difficult to relate the map to the ground and readily identify the proposed new boundaries.

This illogical and confusing definition of the area for removal will result in the potential for future creep of the Green Belt and therefore threatens the permanence of the new boundary defeating the purposes for which this particular Green Belt was originally established. The threat will be enhanced by the construction of the railway line HS2 through the Green Belt to the South.

I therefore consider that the exceptional circumstances required to amend the existing boundaries do not exist for this particular area.

The area at Westwood Heath Road identified as H42 and subsequently the safeguarded area on Westwood Heath Road identified as S2 should not be removed from the Green Belt and should therefore not be allocated for development. This will result in compliance with an appropriate strategy and the relevant paragraphs of the NPPF.

The 420 houses displaced could be allocated to the well-defined but under-utilised King's Hill area H43 or even lost from the current surplus provision in the total figures.

This change will require relevant deletions and amendments to Policy DS15, DS19, Policies Map 35, Policy DS New 1, New paragraph 1.6, Policy DS New 2, Appendix B H42, Appendix B 2.54 and Appendix C New Policies Map 35.
