The location of the access road to the new houses is far from ideal.

The Birmingham Road (and access to it from our estate, Hatton Park) is already very congested. At peak times we have to queue to get onto the Birmingham Road and then queue along the road. The additional traffic generated by 55 new homes will make this much worse. There have also been a number of fatalities and serious accidents on the Birmingham Road in recent years, including a school bus (!), an increase in traffic will increase the likelihood of this happening again.
