① The impact on the village hall and children's play area as well as the Basketball Court. These are very well used facilities by all of Hutton Park residents, the impact would be felt by all generations. Children love to play there, parents would not feel it safe with the proposed access through the village hall car park. Having the sheep and lambs so close to the children's play area is beneficial in those early years in childhood, alongside the recently planted orchard.

② The traffic flowing along Birchenstun Drive has the potential to increase 2fold which raises concerns regarding both noise and emissions pollution. Outgoing traffic from Hutton Park is at full capacity at peak times already adding more dwellings to this would increase more congestion. This in turn increases the chances to road traffic accidents in relation to vehicles and pedestrians going to both work and school.
