7. Please give details of why you consider the Proposed Modifications to the Submission Warwick District Local Plan are not legally compliant or are unsound. Please be as precise as possible. UN SOUND BECAUSE:

- Much of the proposed H50 development increases the risk of flooding in the already flood prone area of lower Cubbington, as it is part of the catchment, by turning existing agricultural fields into part hard surfaces.
- The hydrology of the portion of H50 north of the B4453 needs investigation, as evidenced by the development of significant clear water springs in the vicinity of 2 Thorn Stile Close in periods of heavy rain.
- Insufficient consideration of the stresses caused on the central village shopping area where parking is already inadequate, and on the local small schools.
- Insufficient consideration of the risks of increased traffic on the B4453 at the existing road width and the poor design at the junctions with Coventry Road and Kenilworth Road.
- It constitutes extension of the ribbon development stretching from the centre of Leamington towards Weston under Wetherley, and is green belt land.
