The proposed development appears to be providing Coventry with more housing. If people working in Coventry do choose to live in Leamington, this will produce much more traffic congestion and pollution. The "green lung" between Leamington and Kenilworth will start to disappear. The proposed park-and-ride scheme is, realistically, unlikely to be used. The Green Belt north of Milverton is regarded as having a higher value than the Green Belt areas identified closer to Coventry. The areas closer to Coventry should be used instead. The Green Belt land north of Leamington is long established farmland and should not be lost.
