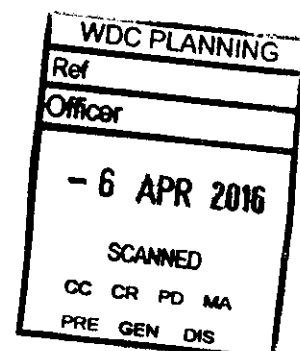

I believe that there are no exceptional circumstances present to enable the removal of the land north of Milverton from the Green Belt. The proposed development will not support Coventry City's housing need as it is unlikely that people who want to live & work in Coventry will buy houses built there, and, more importantly, there are sustainable sites closer to Coventry that should be used in preference to the Green Belt at Milverton to reduce unnecessary commuting, inevitable congestion and more road construction.

I consider that there are no exceptional circumstances present to allocate the land north of Milverton for development. The proposed development will not support Coventry City Council's need for housing, which can be provided at lower value locations nearer to Coventry and without unnecessary impact on roads, congestion etc. The proposed Park and Ride scheme for Leamington Spa is unnecessary when there is already ample parking in the town. Also the 'Green Lung' between Leamington and Kenilworth, as well as highly productive farmland and amenity will be lost if development is agreed.

I believe that the proposed housing development for Coventry City Council housing needs should be located at alternative sites near Coventry which ~~have~~ have lower Green Belt Value and can deliver the required housing needs. The Park and Ride proposal is unsustainable because at this time it is unnecessary.
