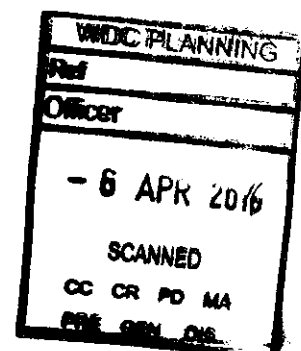

I believe that there are no exceptional circumstances present to enable the removal of the land north of Milverton from the Green Belt. The proposed development will not support Coventry City Council's housing needs, as it is unlikely that purchasers of these proposed properties will work in or commute to Coventry. There is land nearer to Coventry which is more suitable. The proposal will lessen the green lung between Heathcote and Leamington and will remove valuable farming and leisure amenity. The proposed park and ride scheme is unsustainable as its location will be of no benefit and sufficient parking in Leamington means that it will be unnecessary.
