7. Please give details of why you consider the Proposed Modifications to the Submission Warwick District Local Plan are not legally compliant or are unsound. Please be as precise as possible. The modifications presented have not addressed the original issues raised by Baginton Parish Council in relation to Policy DS19. Consequently, our original **OBJECTION** stands and in respect of the changes is summarized below.

The Green Belt within Baginton protects our ancient and picturesque village from inappropriate developments. Its removal is proposed to facilitate the development of current housing stock and to ease the approval of infill housing. However, over the last 12 month, both infill housing and development of current properties have been granted by WDC under the current planning policies. Any that were refused were inappropriate for the village. Therefore, by definition, removing the Green Belt status is to allow these inappropriate developments to go ahead. This is unacceptable and we **OBJECT** to this proposal. Similarly, Baginton Parish Council also **OBJECTS** to the Rosswood Farm (H19) development being on land where Green Belt status has been removed. This development, if allowed, would become part of Baginton and must be protected from future inappropriate development, as discussed above. Baginton Parish Council **OBJECTS** to the removal of Green Belt indicated in Map 8 for Sub Regional Employment. This proposal has already been ruled against by the Secretary of State for a series of very valid reasons and is contrary to the Greenbelt Review. WDC should not be wasting public monies by pursuing a fundamentally flawed plan that would allow Coventry to sprawl unchecked into rural Warwickshire.

Change the WDC Local Plan so that Green Belt status specifically within Baginton Village and at the Rosswood development is retained in order to protect our ancient and picturesque village from future damaging and inappropriate development.

Remove from the WDC Local Plan, all other Green Belt items that are contrary to Local and National Policies, all those which are contrary to the Secretary of State ruling in 2015 and all those which are unsustainable due to significant flaws within the Coventry City Council Local Plan for adjoining areas.

Map 8 is misleading and should be updated. Where Warwickshire borders Coventry City Council, it is misleading and unacceptable for WDC to only present their proposals. If Coventry City Council's planned developments are also added to Map 8, the vast urban sprawl and loss of huge tracts of Green Belt become obvious. Where Warwickshire and Coventry share a border, the combined development must be shown. This is especially true as WDC and CCC are already sharing joint planning applications that straddle the boundary, as with the Jaguar Land Rover applications W/16/0239 and OUT/2016/0405, which BPC have objected to separately in the strongest terms.
