I OBJECT TO AREAS 4, 5, 9 AS THEY ARE IN GREEN BELT WITH NUMBER 9 BEING THE HIGHEST POINT IN THE AREA GIVING A HUGE VISUAL IMPACT.

NUMBERS 4 AND 5 WOULD BE SITED BETTER SOUTH OF HARBURY LANE WHERE GOOD DRAINAGE AND SERVICES ALREADY EXIST ALONG WITH ACCESS TO THE RETAIL PARK. THE LAND IS LOWER THAN SITE 11 AND THE GAP BETWEEN BISHOP'S TALKHROOK WOULD BE GREATER THAN THAT BETWEEN SITE 6 AND RADEFORD SEMELE AND SITE 2 WOULD TOTALLY CLOSE THE GAP BETWEEN WARWICK AND LEAMINGTON AND SITE 2 WOULD BE ON HIGH GROUND CONTRAVENING HEIGHT RESTRICTIONS PLACED ON THE TECHNOLOGY PARK
