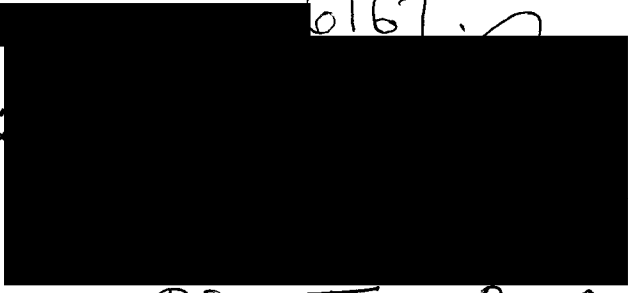

MY OBJECTIONS TO DEVELOPMENT OF LAND AT MILVERTON & ~~BLACKDOWN~~

DEAR SIRS,

THE COUNCIL HAVE FAILED TO PROVE EXCEPTIONAL CIRCUMSTANCES AS PER NATIONAL GUIDELINES WITH REFERENCE TO BUILDING ON GREEN BELT LAND.

THE NATIONAL FIGURES FOR THIS AREA WARWICK = LEAMINGTON SPA = WHITMANA (AKA) KENILWORTH (4 TOWNS) IS AT PRESENT 10,800 HOUSES.
