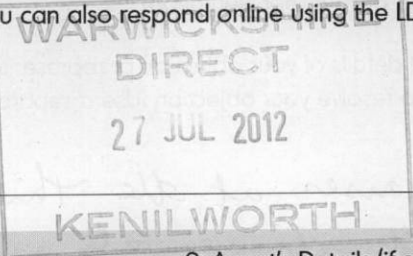

770 houses at the Thickthorn location could be expected to generate approx 1,500 cars. This area of Kenilworth already has severe congestion problems on the roads at junctions (Has anyone actually monitored the congestion at the end of Biches Lane + the Jet garage island?). Making an access to the roundabout at the bypass would in no way help to solve the problem unless these Kenilworth residents were intended to always be travelling towards Leamington which of course they would not. Would access onto Glasshouse Lane be blocked? South + East Kenilworth has already absorbed a huge increase in housing + consequent traffic. I believe that land to the south of Leamington is available for development + has good road infrastructure. Of course developers profits would be lower there. I would like to know if developers profits are being considered rather than the wellbeing of Kenilworth + its residents. If Kenilworth needs to take a share of new housing they should be distributed more fairly + sensibly around the town.
