The preferred Thickenhorn location for 770 houses etc. would totally disfigure the overall nature of Kenilworth. Eastern Kenilworth has been developed already & in excess of what can be considered its natural character. The problem that a 770 house development at Thickenhorn will give, are enormous & that of transport is of major consideration. Major constructional works in several sites will still not solve the problem of moving traffic from Kenilworth to places further South. It will simply add congestion to bottlenecks further along the line.

Why has expansion of the western boundary of Kenilworth not been considered? There is plenty of space. Present roads there could be improved & transport planned to access Birmingham to the North & access to the Warwick - Leamington connection, and beyond.
