Access to the Grand Union Canal at Radford Bottom Lock is extremely dangerous when approaching it from Offchurch Road Radford Leale. The only pavement on the N/E side ends at the village sign and urgently needs to continue and meet up with the pavement at the other side of the canal bridge. Many walkers and cyclists use this road and it is very risky - indeed too risky for others who would wish to have access to the canal at that point. This extra pavement would be costly because of the high bank, but very necessary to avoid accident.
