1. I object to use of green belt land, currently used for leisure activities, walking, cycling, bird watching and dog walking.
2. Potential loss of open space, characterising nature of our region of Leamington Spa.
3. Increase pressure on traffic road routes, specifically along the Keston Rd (already heavily congested at certain times of the day). Northumberland Rd, which already suffers traffic issues i.e. speeding, overtaking, could become a serious problem area.
4. As a health professional working within the maternity services dept at Warwick Hospital, I am concerned that our women receiving care are already accessing a 'stretched' service, due to increasing numbers of patients admitted + poor staffing numbers. Added population numbers would be added pressure on all hospital provision at Warwick Hospital.
5. Suggest use of identifiable available land elsewhere
6. Ensure any demographic changes adequately provided for in relation to local infrastructure + health care provision
