Whitnash has experienced intensive building in recent years to the point that it is unrecognisable from what it once was. The Woodside Farm area is one of the few remaining borders of the older village area and to build housing in this area would further destroy the character of the south side of Leamington Spa.

Despite being farmland the area is also an important haven for wildlife containing many mature hedgerows that cannot be reproduced once destroyed. It is an important habitat and is also one of the few remaining open areas with footpaths used by walkers, runners and people exercising their dogs.

I also have concerns relating to the increase in traffic that is likely to cause many congestion issues and increase the level of danger to people living both in and around Whitnash.

Additionally I am concerned that the hill at Woodside Farm once urbanised will significantly increase run off resulting in flooding.
