

The plans to build at least 90 homes at the bottom of Golf Lane would considerably increase the traffic along an already busy road. The junction with Whitnash Road would become very congested, especially during rush hour. The route through Whitnash, along Morris Drive, would also struggle to sustain such an increased traffic flow.

The local schools are already over-subscribed and a further increase in local residents would mean even more competition for places.

The planned number of homes for this site could easily be incorporated into the plans for larger developments such as South of Sydenham or in the Myton Suburb.

Golf Lane is, at present, a safe, pleasant place to live but if the building work goes ahead it will become a busy, congested road. People choose to live here because of the nearby greenery and space, which will be destroyed by a new housing development.
