 - Traffic volume within Woodlee Park - to/from Doctors (Brose Avenue) to/from Coal Store (Kensway).
 - Risk aggravation to both pedestrian and cyclist users of Woodlee Park.
 - Increased noise pollution that traffic volume generates.
 - Revaluation of Property values that is likely consequence of high density council housing in close proximity to Woodlee Park.
 - Conservation at risk - the biodiverse wildlife/habitat is directly affected and lost
 - Countryside access - the development affects access and enjoyment of the immediate Greenbelt to the local community. (Rights of way).
