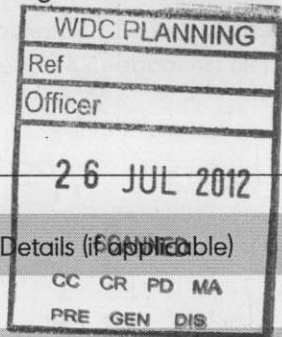

Building on Loes Farm would mean a loss of local biodiversity as identified in the County Museum Habitat Biodiversity Assessment of 2008 which found the site as being unfavourable for development in comparison with other sites on the basis of the ridge and furrow meadow habitat
