




I Live directly next to the Lane where the proposed site for house building <sup>is</sup> in the adjacent fields.

There are numerous reasons for discarding this option; the hedgerows for example, containing many species of plants, thousands of insects, birds & mammals, (hedgehogs, foxes, dormice, newts,). These hedgerows connect to the habitat further up into the fields and create a corridor for all the wildlife. We have seen Buzzards, Woodpeckers, and heard Owls. There is a gap we have purposefully left for the fox and her cubs who regularly come through at night under our fence. I have heard of a Badger being seen further up.

It is a good natural walk for the people who live on the Woodloes, especially the top. The Ramblers regularly have walks up the lane. There is an algae covered pond where Moorhens alone live.

It is a quiet peaceful place for people & animals alike and would be terrible to inflict building on the wildlife who know no different.
