- 2) The hedgerows provide habitat for numerous animals and birds (hedgehogs, foxes, toads, weasels, woodpeckers, buzzards and bats).
- 3) It is a public walkway leading to many other walks to Leek-Wooten etc and it is well used by ramblers because it is quite peaceful.
- 4) Providing 160 more houses would have a major impact on the Woodloes roads which already have trouble in coping with the traffic at peak times.
- 5) The lane provides a corridor for the wildlife from the wetland on the opposite side of the ~~road~~ A46 to the Woodloes and therefore should not be developed.
