
Dear Sir,

I have received information from Radford Semele Parish Council in respect of a proposed development of 100 new houses within the parish of Radford Semele, 40% of which are termed "affordable".

I wish to lodge my total rejection to this or any other plan as follows:

- Vehicle access within the village is already very limited and congestion is very much increasing. It must also be pointed out to you that the main A425 is an arterial road feeding Leamington Spa from the east and carries many heavy lorries throughout the day including fuel tankers. This and the increasing traffic flow and density in Offchurch Lane feeding into the main road makes any certain further increase in traffic by development unsustainable and even more importantly dangerous.
- There is no capacity within Radford Semele school so infants and children would need to travel to alternative venues-not ideal, it is unacceptable and would increase traffic at peak times and increase the carbon footprint.
- There is only limited to nil health facilities in the village-not ideal for any increased population.
- Very limited shops in the area and any additional people would have to travel on existing inadequate road structures.
- Very little local industry for employment.
- Any increase in houses will have a significant and unacceptable impact on the village and adjoining properties and area.
- There is totally inadequate infrastructure at Radford Semele to support this or any other proposed schemes.
- I totally object to any proposed building and development on any land and designated green belt land and there should not be any alteration to the present limits.

- Green belt land is specifically set aside to <u>prevent</u> the following:
 - Urban Sprawl.
 - Towns and villages merging together.
 - It is also there to protect our precious countryside.
- Just because the Government make the proposals it does not mean that they have to carried out.
