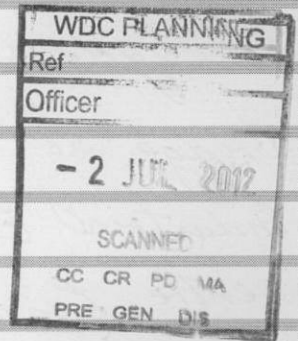

In reference to the preferred option 12 for Fieldgate Lane/Golf Lane Whitnash. In the past we have had many problems with the sewers in this area and I doubt if they would cope with the planned housing. Golf Lane already has problems with traffic congestion. I believe that a large proportion of the traffic from location 6 (Whitnash East/South of Sydenham) would journey under the railway bridge at Fieldgate Lane towards Heathcote Industrial Estate, the M40, supermarkets, the town centre Leamington and schools. I estimate possibly two thirds would choose that route. I do not think Golf Lane or Heathcote Rd, the main road through Whitnash, could cope with that amount of traffic.
