Gypsy and Traveller Site Options Response Form 2013 Site GT01 land adjacent to the Cobalt Centre, Siskin Drive

We write on behalf of M R Beaty and Son of Rock Farm, Bagington, Coventry, CV8 3BB the agricultural tenants of proposed traveller site GT01 to object to the proposed location of Gypsy Site GT01- land adjacent to the Cobalt Centre, Siskin Drive

We note that the site has been assessed in your Warwick Local Plan Final Interim SA Report however would make the following comments based on the selection criteria within your consultation document Sites for Gypsies and Travellers paragraph 7.3.

- You state the site has safe access to the road network. The site has no access to the public 1. highway. In order to access the public highway it is necessary to cross the Middlemarch Business Park.
- The site is located close to Coventry Airport, a business park and disused sewage works. 2. It is inevitable that there will be a degree of noise pollution
- There are no utilities connected to the land and the connection of any utility would be 3. expensive. The adjacent business park uses a pumped sewerage sytem and a similar system would be necessary for the proposed site. This would not be cost effective.
- The land is Green Belt and open in character. It is not possible to integrate the site into 4. the landscape without harming the character of the area. Again for this reason the site should not be selected for further consideration.
- 5. Planning permission is in the process of being granted for the Coventry and Warwick Gateway project. The proposed site forms part of the country park proposed to mitigate

the effects of the scheme. Removal of this land from the scheme will have an adverse effect on the mitigation.

In addition to the criteria we have stated we consider that you should also take into consideration the guidance contained within the National Guidance Planning Policy for Traveller sites March 2012 and make the following comments:

1. Policy C:

Local planning authorities should ensure the scale of such sites does not dominate the nearest settled community.

Whilst adjacent to the business park the proposed location is open in nature. The scale and nature of the proposed travellers site would be overbearing on these and out of context in the locality.

2. Policy E: Green Belt:

National guidance acknowledges that inappropriate development is harmful to the Green Belt and should not be approved except in very special circumstances. It also acknowledges travellers sites are inappropriate development in the Green Belt.

There is no justification within the proposed document as to why Green Belt land is necessary for proposed travellers sites. All of the options identified within the Gypsy and Traveller Site Options are located within the Green Belt or Open Countryside. Locations within settlements especially on brown field options should be reviewed. There is no documentary evidence within the report that this has been carried out and why any brownfield sites within settlements have been disregarded.

3. Policy F: Mixed Planning Use Traveller Sites:

Policy F states that local planning authorities should have regard to sites suitable for mixed residential and business uses to allow residential accommodation and space for storage of equipment. It further states that local planning authorities should not permit mixed use on rural exception sites.

All of the sites identified within the Gypsy and Traveller Site Options would be classed as rural exception sites. Therefore based on Government planning guidance none should be permitted as mixed use sites.

The final selection criteria within part B of your consultation document suggests that the sites will be used for traditional lifestyle i.e. travellers live and work from the same location, however by default none are suitable under National Guidance.

Should any of the sites within the rural environment be considered appropriate the planning authority should consider how it is to be policed, that they will not be used for business purposes including the storage of equipment.

4. Policy H: Decision Taking:

Policy H states that local planning authorities should strictly limit new travellers site development in open countryside that is away from existing settlements or outside areas allocated in the development plan.

All of the locations proposed by the planning authority are within open countryside and it is therefore questioned how these are being strictly limited.

Policy H further states that the local planning authority should attach weight to the previous use of land with previously developed brown field untidy or derelict land being most suitable. Whilst this site is brownfield there are no buildings on it.

We would also refer to National Planning Policy Framework and in particular Protection of Green Belt Land.

Of the five purposes stated for the establishment/ maintaining of green belt within paragraph 80 of the National Planning Policy Framework the proposed site contravenes at least two in that it does not safeguard the countryside from encroachment or protect the unrestricted sprawl of large built up areas. The National Planning Policy Framework further suggests that inappropriate development is harmful to the Green Belt and should not be approved except in very special circumstances. Very special circumstances will not exist unless the potential harm to the Green Belt by reason of inappropriateness and any other harm is clearly outweighed by other considerations. No justification is provided within the consultation document as to why special circumstances exist for the proposed change of use and therefore the development is inappropriate.

For the above reasons we do not consider site GT01 is an appropriate site for a traveller and gypsy site and it should not be considered by the District Council as an appropriate site to take forward.
