In the town of Kenilworth there are over 115 properties at risk of flooding at the 100 year level and a number of these are alongside Finham Brook, a main river, which drains the town. The proposed modifications to Policy DS10 introduce 2,245 houses on land on the edge of Coventry which will drain either directly or via Canley Brook into Finham Brook; not to mention the 93 at Crackley and others within Kenilworth. There is also relevant existing and planned development within Coventry itself and further development on the extensive campus of the University of Warwick. To cap it all the route of HS2 crosses this area. Whilst each individual site sustainability analysis may contain reference to drainage and flooding most of that concerns the site itself rather than subsequent effects downstream. We have not been able to find an analysis of the combined effect of all this development on the flooding risk in Kenilworth town.
