WHILE IN PRINCIPLE POIS MEETS THE NEED FOR CREATING INCUSIVE, SAFE + HEALTHY COMMUNITIES, I FEEL THAT THERE ARE SOME UITAL AREAS NOT COURSED.

SCHOOLING: I FEEL THAT WIDE SHOULD ADOPT PARAGRAPH 72 FROM THE NOPF AND INCLUDE IT IN POBS ALONZ WITH DETAILS OF HOW THEY PROPOSE TO DELIVER ON IT.

IT DETAILS THAT IN ENSURING LOCAL COUNCILS OFFER "SUFFICIENT CHOICE OF SCHOOL PLACES... TO MEET THE WEBDS OF EXISTING AND NEW COMMUNITIES" THEY SHOULD "WOOLE WITH SCHOOL PROMOTERS TO IDENTIFY AND RESOLVE KEY PLANNING ISSUES" AND ALSO "GIVE GREAT WEIGHT TO THE NEED TO CREATE, EXPAND OR ALTER SCHOOLS".

THIS IS ESPECIALLY IMPORTANT GIVEN THE GOVERNMENTS PROMOTION OF FREE SCHOOLS I AND IT SHOULD BE RECOGNISED THAT WOL ARE IN ACCORD WITH THIS.

FAITH: I FEEL THAT THERE IS A NOTICEABLE ABSENCE IN REFERENCES TO
FAITH AND HOW IT IS LINKED TO SOFE AND HEALTHY COMMUNITIES. AS A
CHRISTIAN I FEEL THAT RECOGNITION SHOULD BE MADE TO THIS FUNDAMENTAL
LINK AND THAT WOLL SHOULD MAKE STRONG AND DEFINATE POLICY WHICH
ALCOWS FOR THE ACTIVE PROMOTION OF FAITH IN OUR COMMUNITIES. THIS WOULD
INCLUDE PROVISION FOR PLACES OF WORSHIP IN ALL NEW AND EXISTING
DEVELOPMENTS.
